7. Innovations and Best Practices

7.1 Innovations introduced during this academic year which have created a positive impact on the functioning of the institution. Give details.

- In the beginning of the academic year a review of the achievements in the curricular and co-curricular activities of the academic year 2012-2013 was undertaken.
- In order to streamline the impOlementation of the academic programmes departments were encouraged to prepare their own academic calendar. It enabled to have department wise and programme wise preparation of academic schedules.
- Departments were encouraged to offer orientation programme for beginners with special focus on Career Orientation.
- Motivational programmes, Moral and Ethical lessons, Civic Responsibilities and programmes of personality developments are periodically arranged for the benefit of the students.
- Institutional provides great significance o gender equity. The Women's Cell and the Women Empowerment Cell organized special programmes to sensitize gender issues.
- In the teaching learning process slow learners are identified through a multiple process including Entry Level Assessment. It enables to chalk out special programmes including remedial sessions for the weak and slow learners. In the same line we could organize some special activities for the advanced learners. They represent the college in different programmes and competitions.
- Principal along with the IQAC co-ordinator reviews the implementation of the curricular and co-curricular programmes to ensure quality sustenance and improvement. It is in the form of an academic audit by the college.
- The PTA meetings both general and department level enable to have close interaction between parents and class teachers. It helps to monitor the academic progress of students.
- Capacity enhancement programmes for the teaching and non-teaching staff in areas like ICT, Management of learning resources, service rules and office matters.
- The area of research and extension faculty members and students to encourage interdisciplinary projects and studies. The students of departments of Biosciences do project works in the departments of Chemistry and Zoology.
- Students support services including Noon Meal Scheme, Book Bank Scheme, Net Facility, Scholarships and Endowment and training programme for competitive examinations enabled students to make the learning process in an effective manner.

- 7.2 Provide the Action Taken Report (ATR) based on the plan of action decided upon at the beginning of the year
 - A systematic mechanism was formulated for the effective and time bound implementation of credit and semester system in the context of restructured syllabus. Efforts were made to ensure the required contact hours for the administering of each course.
 - A new tier of co-coordinators for the implementation of CBCSS Programmes was formed. One representative from each UG departments was nominated by the respective departments. They were given training in the implementation of the Programmes.
 - Training programmes by inviting experts were arranged for the faculty members in the area of the reformulated grading system.
 - In the restructured syllabus two internal examinations are mandatory. A centralised system was devised by the Examination Committee for conducting internal examination in an efficient manner.
 - PTA meetings were reorganised. In the place of general PTA, department level PTA meetings were convened. In some departments progress card of the students were distributed at the time of PTA meetings. Involvement of parents in the administering of Programmes can be ensured through this process.
 - In order to promote slow learners special classes were organised and learning materials were given.
 - Departments were encouraged to organise community extension Programmes in their respective areas. The sharing of expertise for the benefit of the local community was given more importance.
 - Proposal were submitted to the University for the introduction of more number of Vocational Programmes.
